

**Sub: - Payment to the Home Guard volunteers deployed with the MeECL.**

**Ref: - U/O. No.G.57/2008/349, dated 16.10.2012.

In inviting reference to the above, I write this to say that the management of MeECL has vide Office Order dated 20.12.2012 fixed a total amount of Rs.8917/- per month to be paid to the Home Guard volunteers deployed with the MeECL.

It may be mentioned here that, as informed vide my abovementioned U/O. note, in case of Home Guard volunteers who discharge duties without arms, the Government has fixed duty allowance of Rs.300/- per day and washing allowance of Rs.100/- per month. Thus the revised amount fixed by the MeECL is less than the amount fixed by the Government.

Besides, as pointed out in my abovementioned U/O. note, as regards the Home Guard volunteers who discharge duties with arms, all other 13 requisitioning Departments / agencies are paying basic pay of Rs.7700/- plus all other admissible allowances that are paid to the Government employees.

Since we have the largest number of Home Guard volunteers (385) deployed with the MeECL and since they have, over the years, been discharging their duties with utmost sincerity and dedication and have been discharging the same duty as the regular security staff of MeECL including the same hours of duties, I would request for kind intervention of the CMD, MeECL in ensuring that justice is done to them in the matter of monthly payments made to them. It may kindly be ensured that the Home Guard volunteers who are discharging duties without arms are paid not less than Rs.300/- per day as duty allowance plus Rs.100/- per month as washing allowance

with effect from 27.08.2012 (the date on which duty allowance and washing allowance were revised by the Government), and those who are discharging duties with arms are paid Rs.7700/- as basic pay plus all other admissible allowances that are paid to the Government employees.

It may be mentioned here that a letter to this effect was earlier addressed to the Under Secretary MeECL vide No.G.57/2008/368 dated 11.01.2013.

Sub:- Payment of increased amount of Duty Allowance and Washing Allowance to Home Guard Volunteers.

Ref:- Your letter Memo No. Me.ECL/CA/PER/HG-Requisition /37/2010/Pt/30 (a), dated 20<sup>th</sup> December, 2012.

Sir,

In inviting reference to the above, I am directed to say that as informed vide U/O No.G.57/2008/349, dated 16.10.2012 addressed to CMD, Me.ECL (Copy enclosed for ready reference), in case of Home Guard Volunteers who discharge duties without arms, Govt. has vide No.HCD.37/2002/57, dated 22.08.2012 fixed the Duty Allowance at ₹. 300/- per day and Washing Allowance at ₹.100/-. Thus the amount of Duty Allowance fixed by Me.ECL is less than the amount fixed by the Govt. and besides, there is no provision of Washing Allowance .


Again, as informed vide our above mentioned U/O Note, in case of Home Guard Volunteers who are discharging duties with arms, all other requisitioning Departments /agencies are paying Basic Pay of ₹. 7700/- plus Allowances.

In view of the above, it is again requested that in case of Home Guard Volunteers who discharge duties without arms, Duty Allowance at ₹.300/- per day and Washing Allowance at ₹. 100/- per month may be paid and in case of Home Guard Volunteers who discharge duties with arms, the Basic Pay of ₹.7700/- plus Allowances may be paid.

It is requested that decision in this regard may kindly be obtained and communicated at an early date.
